NAPS Releases List of SPAC-Supported Congressional Candidates

Today, the National Association of Postal Supervisors (NAPS) released a list of members of Congress, and House and Senate candidates that SPAC, NAPS' political action committee, is supporting in the 2018 congressional election. In total, SPAC has contributed to 137 congressional campaigns in the upcoming election.

The future viability of the U.S. Postal Service and the preservation of postal employee earned benefits are critical to NAPS and its members. In addition, postal accessibility and affordability are critical to a vibrant national economy and the vitality of countless rural communities.

NAPS continually encourages members of Congress to promote legislation that recognizes the prominence of the Postal Service and the importance of management-level employees who ensure the Postal Service operates efficiently and with high quality. The Supervisors Political Action Committee (SPAC) is NAPS' political war chest and is financed through the generous donations of NAPS members, helps elect current and future NAPS allies. NAPS has compiled the following select list of House and Senate candidates running in 2018 who are worthy of the support of NAPS members voting in their respective districts and states.
